### REGULATION ON TRACK RENTAL – EXCLUSIVE LEASE

When track on Automotodrom Grobnik is exclusively rented for organization of motorcycle /car trainings and races that are not in jurisdiction of FIA, FIM; FIM Europe , HAKS or FMNR and when their licenses and Regulations do not apply, following regulations DO apply:

1. Minimum 15 track marshals on the track
2. Minimum 1 ambulance for free practices  
Minimum 2 ambulances for the races
3. Medical team is consisted of doctor, medical technician and driver
4. In case all ambulances leave Automotodrom Grobnik for purpose of transport to the clinic or providing medical help, the event will be stopped by the time first medical vehicle is back on the track and time loss will not be compensated
5. Other services (timekeeping, firemen squad, audio system,towing service... ) will be organized and ordered according to the request of the organizer
6. Timekeeping service has 130 transponders available; if organizer requires over 130 transponders he has to specify it and order
7. The organizer must sign the contract before the start of the event, and any kind of cancellation of the ordered and organized services on the day of the event is NOT possible (for ambulances time frame for cancellation is 24 h before the start of the event)
8. Additional ordering of the services on the day of the event is possible only in case that they can be organized and responsible person from AG (Co-ordinator for manifestations and sport) is obligated to write down all changes in the official document- the record of the event
9. Before the start of the event the Organizer is obligated to hand over the program and timetable to the Co-ordinator for manifestations and sport of AG.
10. Co-ordinator for manifestations and sport is managing independently the event according to the Organizer's program and timetable
11. 40 cars/ 48 motorcycles can participate in free practices and 40 cars/40 motorcycles in the races
12. All riders/drivers and passengers must have complete equipment (suit or jacket with trousers with appropriate protection, helmet, gloves and boots-for moto, helmet –for cars)
13. Only rider can be on the motorcycle
14. Driving as a pair or without adequate equipment (auto/moto) is possible only in special terms (recreational and panoramic ride) and to the responsibility of the Organizer.
15. Prolonging the event on the same day is possible only in case all services can be organized, and responsible person from AG (Co-ordinator for manifestations and sport) is obligated to write down all changes in the official document- the record of the event
16. After the completion of the event any form of riding/driving with motor vehicle on the track is strictly forbidden
17. In case the Organizer has the sublease of the boxes Co-ordinator for manifestations and sport is obliged to hand over to him all the keys before the start of the event. Riders/Drivers who use boxes must leave them with all the equipment latest 1h after the finish of the event and the Co-ordinator for manifestations and sport is responsible for accuracy of the data on the list of boxes. In case of disrespecting this time frame, the Organizer will be charged additionally for 1st hour 20€ and afterwards for every additional hour another 50€
18. On the end of the event the Organizer is obliged to sign the document with the list of used services on Automotodrom Grobnik
19. Automotodrom Grobnik is not responsible for the consequences caused by disrespect of above mentioned acts
20. All events on Automotodrom Grobnik can be covered by media (photo, video etc..)
21. Any photographing or filming inside the facility without prior written approval or the existence of a contract with Automotodrom Grobnik d.o.o. it is strictly forbidden.
